#### APPROVAL CONDITIONS FOR MANUFACTURER APPROVAL GRANTED TO LIMITED LIABILITY COMPANY "WEST-ENGINEERING"

#### **Definitions**

Article 1 - (1) Within the scope of this approval each term below is defined as indicated:

- a) Authority: Nuclear Regulatory Authority
- b) Decree Law: Decree Law No. 702 dated 2/7/2018 on the Organization and Duties of the Nuclear Regulatory Authority and Amendment on Other Laws, published in the Official Gazette No. 30473, dated 9/7/2018
- c) Owner: Legal entity recognized by the Authority to build a nuclear facility
- d) Regulation: The Regulation on Equipment Procurement Process for Nuclear Facilities and Approval of Manufacturers published in the Official Gazette No. 29369, dated 28/05/2015

#### **Legal Basis**

Article 2 - (1) These approval conditions have been prepared by Nuclear Regulatory Authority on the basis of the Decree Law according to the Article 5, paragraph (4) of the Regulation.

#### Owner and Scope of Approval

- Article 3 (1) Manufacturer Approval: Granted to Limited Liability Company "West-Engineering" registered at the address of 22 Moiseenko Street, litera Z, pom. 24-H, room 324, Saint-Petersburg, 191144, Russian Federation with the code of TR-IMO-055.
- (2) Within the scope of this Manufacturer Approval, Limited Liability Company "West-Engineering" can manufacture equipment for nuclear facilities being established in the Republic of Turkey whose list is given in the Appendix 1.
- (3) Limited Liability Company "West-Engineering" is subject to the inspection by the Authority as long as the approval is valid. The Authority may conduct an aucit to check that the approval validity conditions are met and / or the manufacturing process of the equipment produced. While the Authority inspectors perform their duties, they have the authorization to access facilities and places where the activities are covered by the approval as well as related documents, records and employees.
- (4) Manufacturer Approval cannot be turned over to other legal entities including organizations that are connected to or partner with Limited Liability Company "West-Engineering".
- (5) Manufacturer Approval granted to Limited Liability Company "West-Engineering" is valid for 5 years from the date of the approval.

#### **Responsibilities of Approval Owner**

Article 4 - (1) Limited Liability Company "West-Engineering" shall have staff with required number and competence level in order to continue the activities within the scope of approval and to manufacture with required quality (as necessitated for the safety class to which the manufactured equipment belong) for equipment safety class.



(2) Limited Liability Company "West-Engineering" provides access to facilities or venues to Authority inspectors providing that it complies with the purpose of the inspection, ensures that, if requested by Authority inspectors, all documents necessary for inspection shall be made available including records of the problems that arise and also provides suitable environment for conducting the inspection including keeping an interpreter.

- (3) Limited Liability Company "West-Engineering" shall notify to Authority all kinds of changes of organization and infrastructure that necessitates modification of the conditions of the approval.
- (4) Limited Liability Company "West-Engineering" performs the procurement process of the equipment to be manufactured for the nuclear facilities which are constructed in the Republic of Turkey in accordance with;
  - a) Relevant legislation of the Republic of Turkey,
  - b) Technical documents of the Owner about the design and manufacturing,
  - c) Codes and standards specified by the Owner,
  - d) Implemented quality management system requirements.

#### **Making Replacement or Addition of Approval Conditions**

- Article 5 (1) The Authority can make changes to these conditions of approval in order to guarantee nuclear safety. If changes have been made, Authority notifies new approval conditions to the Limited Liability Company "West-Engineering".
- (2) Limited Liability Company "West-Engineering" can apply for making changes to these approval conditions to the Authority. Application must include the reason for the change, evaluation of the change regarding nuclear safety and the new text of the conditions. These changes can only take effect by confirmation of the Authority and the Authority notifies new approval conditions to Limited Liability Company "West-Engineering".

#### The List of Documents Taken Into Consideration

**Article 6 -** (1) Approval of manufacturer was given according to evaluation of the documents given in Appendix 2 and submitted by Limited Liability Company "West-Engineering" during application period.

#### **Cancellation Policy of Approval and Enforcements**

- Article 7 (1) Approval of manufacturer can be cancelled according to evaluation of the Authority in terms of the importance of the breach if;
  - a) Scope of given authority as defined by this legislation of approval conditions is exceeded, or
  - b) Obligations defined in the approval conditions are not fulfilled.
- (2) If it is understood that Limited Liability Company "West-Engineering" does not have the required qualifications in terms of relevant regulation anymore or in case of determination of non-conformities or deviations during the evaluation and inspection activities throughout validity of approval period, Limited Liability Company "West-Engineering" is requested to prepare an action plan in order to correct the problems during the time period determined by the Authority. The action plan includes the corrective and preventive actions, implementation schedule of them and reporting of the



results to the Authority. If the Authority considers the action plan appropriate, it is put into practice and the Authority can carry out an inspection if it is deemed necessary. If the problem is not fixed within the time specified in action plan, approval of manufacturer can be cancelled according to evaluation of the Authority in terms of the importance of the problem.

(3) During inspections of the Authority, approval of manufacturer can be cancelled in such cases; lack of cooperation with Limited Liability Company "West-Engineering", lack of providing documents and information and falsifications of documents.
